Late Reporting Forms

There are still over 50 relief associations that have yet to submit some or all of their 2005 reporting year forms. **Complete** and **correct** reporting information must be received before November 30 to avoid forfeiture of your 2006 state fire aid. The reporting forms should be submitted as soon as possible so that they can be reviewed and so that you can ensure correct reporting information has been filed. Unfortunately, we have received forms that were prepared by relief associations or their accountants that were not completed correctly and had to be sent back to be revised and re-filed. All reporting information, including complete and correct reporting forms, must be received to comply with the statutory forfeiture deadline.

Please make sure that reporting information is submitted directly to the State Auditor's Office.

Bylaw Changes

The State Auditor's Office has received numerous inquiries regarding recent law changes and whether the changes require that your bylaws be updated. The law changes related to volunteer fire relief associations don't directly require that your bylaws be amended. If your relief association is interested in offering the increased supplemental benefit to survivors, the bylaws do need to be updated to reflect this new option. The investment authority changes and definition of the term "Volunteer Firefighter" do not require that you amend your bylaws. Your relief association's investment advisor or broker should be made aware of the investment authority changes and your fire department should be notified of the firefighter definition.

The July 2006 Pension Newsletter contained a summary of the law changes that occurred this past summer. Another copy of the July newsletter is accompanying this newsletter for your convenience.
