### *Working Group Update*

The Office of the State Auditor's Volunteer Fire Relief Association Working Group held its second meeting of the year on Thursday, November 1. The Group discussed issues surrounding ancillary benefits, which are disability, survivor, and funeral benefits. Discussions focused on whether authority should be granted to pay reduced ancillary benefits for members that are not fully vested and whether the definition of surviving spouse should be updated to reflect the definition used by the Public Employees Retirement Association. After very thorough discussions the Group decided to hold over both topics to the next meeting so that members could think about these complex issues and obtain additional information. The Working Group members also discussed setting a minimum age requirement for disability benefits and decided to take no action on the topic.

### *Forfeiture Deadline*

There are still about 30 relief associations that have yet to submit some or all of their 2006 reporting year forms. All reporting information must be submitted by November 30 to avoid **forfeiture of state fire aid**. Numerous notices have been sent by mail and email to the late relief associations and affiliated municipalities. ### *Second Certification Deadline*

The Office of the State Auditor is pleased to announce that 144 volunteer fire relief associations and other entities met all reporting requirements to be certified as eligible for receipt of their state aid in the second round of aid disbursements. The second certification deadline for state aid was November 1, with aid payments being disbursed on or about November 15. A listing of the fire state aid amounts is posted on the Office of the State Auditor's website. Click on the link to "Forms," on the left side of the main page and then click on "Pension." Finally, click on the link to "2007 State Fire Aid Amounts."

***Selected Relevant Statutes Booklet***
