Description of the Office of the State Auditor

The mission of the State Auditor's Office is to oversee local government finances for Minnesota taxpayers by helping to ensure financial integrity and accountability in local governmental financial activities.

Through financial, compliance, and special audits, the State Auditor oversees and ensures that local government funds are used for the purposes intended by law and that local governments hold themselves to the highest standards of financial accountability.

The State Auditor performs approximately 160 financial and compliance audits per year and has oversight responsibilities for over 3,300 local units of government throughout the state. The office currently maintains five divisions:

Audit Practice - conducts financial and legal compliance audits of local governments;

Government Information - collects and analyzes financial information for cities, towns, counties, and special districts;

Legal/Special Investigations - provides legal analysis and counsel to the Office and responds to outside inquiries about Minnesota local government law; as well as investigates allegations of misfeasance, malfeasance, and nonfeasance in local government;

Pension - monitors investment, financial, and actuarial reporting for approximately 730 public pension funds; and

Tax Increment Financing, Investment and Finance - promotes compliance and accountability in local governments' use of tax increment financing through financial and compliance audits.

The State Auditor serves on the State Executive Council, State Board of Investment, Land Exchange Board, Public Employees Retirement Association Board, Minnesota Housing Finance Agency, and the Rural Finance Authority Board.

INDEPENDENT AUDITOR'S REPORT ON APPLYING AGREED-UPON PROCEDURES

Board of Directors
Nokomis East Neighborhood Association

We have performed the procedures enumerated below, which were agreed to by the Nokomis East Neighborhood Association (NENA) and the Minneapolis Neighborhood Revitalization Program Policy Board (NRP), solely to assist you with respect to ensuring adequate accounting procedures and other practices are being followed to account for and report on the use of NRP funding being provided to the NENA. These procedures were applied to the NENA's records as of December 13, 2006. This engagement to apply agreed-upon procedures was performed in accordance with standards established by the American Institute of Certified Public Accountants. The sufficiency of the procedures is solely the responsibility of the NENA and the NRP. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

1. Procedure

Determine if the NENA is current with required filings (Attorney General, Secretary of State, and Internal Revenue Service).

Findings

2. Procedure

Determine if the NENA has written policies and procedures for financial operations (receiving, disbursing, purchasing, personnel, conflict of interest policy, etc.).

3. Procedure

Determine if the procedures the NENA has in place over cash accounts, payroll, receipts, and disbursements are adequate for its operation.

PREVIOUSLY REPORTED ITEM NOT RESOLVED

96-1 Segregation of Duties

Due to the limited number of office personnel within the NENA, segregation of the accounting functions necessary to ensure adequate internal control is not possible. This is not unusual in operations the size of the NENA; however, management should constantly be aware of this condition and realize that the concentration of duties and responsibilities in a limited number of individuals is not desirable from an accounting point of view.

Client's Response:

NENA is aware that, as a small organization, adequate segregation of duties is difficult to achieve. We have taken steps over the years to strengthen internal controls whenever possible. NENA board members are mindful of the limitations inherent in the size of our operations and the need for continuous oversight of our financial operations.

PREVIOUSLY REPORTED ITEM RESOLVED

Coding of Expenses (04-1)

Our previous report noted that some expenses were coded incorrectly to the NRP program because it was not clear where the expenses should be coded.

Resolution

Our current review found that expenses contained the correct coding.

4. Procedure

Determine if the NENA has procedures in place to account for donations, fixed assets, and long-term obligations.

Determine if accounting records support the NRP amounts requested for reimbursement.
