

## Appendix 2 1996 and 1997 Budgeted Revenues and Expenditures by County

### Explanation of Appendix 2 Tables

Budget data used in this report are unaudited revenues and expenditures reported to the Office of the State Auditor by Minnesota counties. The form (see Appendix 3 on page 59) used to collect this information requested that counties provide three types of data: *1996 budget*, *1996 amended*, and *1997 budget*.

The *1996 budgets* are the 1996 budgets adopted by county boards in November and December of 1995. Some counties submitted 1996 budgets that were revised from what they submitted to the OSA last year. **Therefore, the 1996 budgets presented in this report should replace those found in last year's report.**

The *1996 amended* data represents budgets that have been changed (amended) during 1996. The *1996 amended* data was not used in the analysis but is provided for further understanding of counties' financial situations.

The *1997 budgets* are the 1997 budgets adopted by county boards in November and December of 1997.

The analysis of the data presented in this report focuses solely on the 1996 and 1997 budgets.
