### **1999 and 2000 Budgeted Revenues and Expenditures by County**

#### **Explanation of Appendix 2**

Budget data used in this report are unaudited revenues and expenditures reported to the Office of the State Auditor by Minnesota counties. The form used to collect this information requested that counties provide three types of data: *1999 budget*, *1999 amended*, and *2000 budget*.

The *1999 budgets* are the 1999 budgets adopted by county boards in November and December of 1998. Some counties submitted 1999 budgets that were revised from what they submitted to the OSA last year. **Therefore, the 1999 budgets presented in this report should replace those found in last year's report.**

The *1999 amended* data represent an estimate of the counties' final 1999 budget as amended by the county. The inclusion of this data is intended to give county officials an opportunity to show any major changes that may have occurred between the adoption of the 1999 budget in late 1998 and the close of the 1999 calendar year. The *1999 amended* data was not used in the analysis, but is provided for further understanding of counties' financial situations.

The *2000 budgets* are the 2000 budgets adopted by county boards in November and December of 1999.

The analysis of the data presented in this report focuses solely on the 1999 and 2000 budgets.
