2003 and 2002 Budgeted Revenues and Expenditures By County

Explanation of Appendix 2

Budget data used in this report are unaudited revenues and expenditures reported to the OSA by Minnesota counties. The form used to collect this information requested that counties provide three types of data: *2002 budget*, *2002 amended*, and *2003 budget*.

The *2002 budgets* are the 2002 budgets adopted by the county boards in November and December of 2001. Some counties submitted 2002 budgets that were revised from what they submitted to the OSA last year. **Therefore, the 2002 budgets presented in this report should replace those found in last year's report.**

The *2002 amended* data represent an estimate of the counties' final 2002 budget as amended by the county. The inclusion of this data is to give county officials an opportunity to show any major changes that may have occurred between the adoption of 2001 budget in late 2001 and the close of the 2002 calendar year. The *2002 amended* data was not used in the analysis, but is provided for further understanding of the counties' financial situations.

The *2003 budgets* are the 2003 budgets adopted by county boards in November and December of 2002.

The analysis of the data presented in this report focuses solely on the 2002 and 2003 budgets.

Blank tables indicate those counties that did not file their summary budget report with the Office of the State Auditor.
